- the Bank is only able to process my redraw request between 9:30am to 4:30pm on business days (normally Monday to Friday) and if a redraw request is received by the Bank outside business hours, the Bank will process the redraw on the next business day; • credit of the redraw to the Nominated Account may not be available for withdrawal for up to 5 working days; • a redraw fee and other fees may apply as provided in my loan agreement; • redraw is not available for Secured Personal Loans; • the above redraw request will not be processed if it contravenes the terms of the loan agreement in which case I accept full responsibility for such failure and will not seek any recourse against the Bank.
- I have not dealt with any security interest connected with my loan without the Bank's consent; • I am not relying on any statement or representation by the Bank (including its employees) in relation to taxation consequences of making a redraw.
